Line 28. RAZOM AID PROGRAM

Razom AID provides humanitarian assistance to those most affected by the crisis in Ukraine. As part of Razom AID program, the following aid has been delivered:

- Under the Toy Drive project, two 40 foot container of aid were sent to families in Ukraine. Also under this project, over 250 families have been contacted by volunteers and received personalized care packages with aid such as clothing, toys, and school supplies. 3,000 diapers were delivered to 76 families
- Razom has supported hospitals in Ukraine by providing medical equipment not previously available in the country.
- Razom has provided clean water to the civilians in conflict zones in Ukraine by purchasing and shipping water filters. Razom has also sent hand warmers to civilians during the winter months.

Line 29. RAZOM THINK PROGRAM

Razom THINK works to incorporate perspectives from Ukraine into the academic agenda of western nations through collaboration with universities, think tanks, non-profits, and Ukrainian leaders.

In 2015, Razom produced an independent legal report on the human rights situation in Ukraine titled "Human Rights on Occupied Territory: Case of Crimea". The report was presented in United Nations, Congress, European Parliament, to civil society organizations in Ukraine, and at universities in New York, Antwerp, Kyiv, and Lviv. A crucial part of this report is a Human Rights Protection Manual which aims to provide Crimeans of all ethnic and religious groups with access to justice by explaining their fundamental rights. It is Razom's intent and hope that this Manual will help lay people in Crimea learn how to protect their rights.

In 2015, Razom continued to develop the OKO project, which monitors media mentions of Ukraine. One of the biggest accomplishments of the project during this year was the production of a report on media coverage of the MH17 tragedy.

Line 30. RAZOM PARTNERS PROGRAM

Razom Partners acts as organization that collects and distributes information about outstanding giving opportunities related to Ukraine.

In 2015, Razom Partners program support the following projects:

- Support hospitals in Ukraine, which sends containers of surplus medical equipment to hospitals in Ukraine
- Wounded Warrior Ukraine, which provides support to veterans with PTSD.
